(a) General Description (Cont'd)

NetPoint<sup>SM</sup>2 (2-way)\* - provides for 2-way (C)  
originating and terminating data traffic.  
NetPoint<sup>SM</sup>2 may be used to originate voice  
calls (from the customer to the Telephone  
Company), provided that such calls  
originate from a computer or similarly  
functioning device and must undergo a net  
protocol conversion prior to completion to a  
telephone number assigned in accordance  
with the North American Numbering Plan  
and associated international agreements.

The basic configuration for NetPoint<sup>SM</sup> is twenty-  
three (23) 64 kbps B-channels and one (1) 64 kbps  
D-Channel for a total transmission rate of 1.544  
Mbps.

NetPoint<sup>SM</sup> provides an industry standard digital  
connection which offers customers access to a  
variety of network services and features.
