1. With this filing, Verizon is providing the following revisions to IntelliLight® Broadband Transport Service (IBT) in its Tariff FCC Nos. 1 and 11:

- a. Adds regulation to allow connection of IBT at OC192/OC192C speed to IntelliLight® Optical Transport Service (IOTS). Currently, connections are allowed at OC3/OC3c, OC12/OC12c and OC48/OC48c to protected IOTS optical transport channels. In addition, this filing will modify regulations to allow connections to unprotected IOTS optical transport channels at all the aforementioned speeds.
- b. Clarifies that the Four Fiber 1+1 Protection Optional Feature is not available when IBT is connected to Protected IOTS.
- c. Clarifies that Fiber Path Diversity Optional Feature is required when IBT is connected to Protected IOTS and is not available when IBT is connected to Unprotected IOTS.

2. With this filing, Verizon is removing expired promotions from its Tariff FCC No. 20.

Supporting information specified under 61.49 of the Commission's Rules is not required with this filing.
