19. Promotional Offerings19.1 General

The Telephone Company may, from time to time, engage in special promotional service offerings, special arrangements or demonstrations designed to attract new customers, to stimulate customer usage and/or to increase existing customer awareness of Telephone Company products and services.

These promotional offerings will be limited to certain dates, times and locations as determined by the Telephone Company. The rates, charges, terms and/or conditions applicable to each promotional offering will be filed in this section.

19.2 Terms, Conditions, Rates and Charges

The specific rates, charges, terms and/or conditions for the promotions offered by the Telephone Company are described following:

(A) Sprint Custom Access SolutionsSM

The Sprint Custom Access SolutionsSM promotion waives the nonrecurring charges, as set forth in 8.7.5 preceding, when a customer installs a new Sprint Custom Access SolutionsSM arrangement under a three year minimum service period.

In the event the customer terminates its Sprint Custom Access SolutionsSM arrangement prior to the expiration date of the three year term, any nonrecurring charges waived under this promotion will be included in the calculation of the customer's termination liability charges as set forth in 8.7.2(A) preceding.

The promotion will begin on September 3, 2005, and will apply to all new Sprint Custom Access SolutionsSM orders through December 31, 2005. The promotion is available to all customers served by suitably equipped Telephone Company wire centers identified in the National Exchange Carrier Association, Inc. Tariff F.C.C. No. 4.
