Under authority of Special Permission No. 05-056 of the Federal Communications Commission, Verizon is submitting tariff pages to reformat existing tariff regulations for its dedicated SONET ring service offerings by proposing the following:

1. Verizon's dedicated SONET ring offerings are named IntelliLight[®] Dedicated SONET Ring in Tariff F.C.C. Nos. 1 and 11 and Verizon Dedicated SONET Ring in Tariff F.C.C. Nos. 14 and 16. For Tariff F.C.C. Nos. 1 and 11, IntelliLight[®] Dedicated SONET Ring is renamed to Verizon Dedicated SONET Ring.

2. The regulations for Switched Access Verizon Dedicated SONET Ring are combined with the regulations for Special Access Verizon Dedicated SONET ring into a single set of regulations for the service in Tariff F.C.C. Nos. 1 and 11. However, separate Universal Service Order Codes and rates are retained for both Switched Access and Special Access Verizon Dedicated SONET Ring.

3. Verizon Dedicated SONET Ring regulations for Verizon's Tariff F.C.C. Nos. 14 and 16 are also being reformatted in order to align the regulations with the newly created format in Tariff F.C.C. Nos. 1 and 11.

Supporting material as specified under Sections 61.49 of the F.C.C.'s Rules of the Commissions Rules is not required with this filing. However, a document is attached that describes in detail the tariff revisions included in this transmittal. In addition, attachments are included that provide side-by-side comparisons for Tariff F.C.C. Nos. 1 and 11. These attachments provide a side-by-side comparison of every regulation as it currently appears in Section 6 (Switched Access Services) and in Section 7 (Special Access Services) and the consolidated regulation that now appears in the new section (Section 23.1 for Tariff F.C.C. No. 1 and Section 34.1 for Tariff F.C.C. No. 11). Any differences between the Section 6 and the Section 7 regulation are bolded in the side-by-side comparison. Bold text is also used in the combined regulations to highlight any revision that Verizon made in Section 23.1 of Tariff F.C.C. No. 1 or Section 34.1 of Tariff F.C.C. No. 11 that does not appear in either Section 6 or Section 7 of the associated tariff.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$720.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically over ETFS.
