With this filing, Verizon is removing Electronic ReQuest® Service as an offering from its Tariff F.C.C. No. 1 and NYNEX Electronic White Pages Service as an offering from its Tariff F.C.C. No. 11. There has been no customer demand for these services since May 2005. Advances in technology have made these services obsolete because of a requirement for an access service of Public Data Network (FCC1) or InfoPath packet switching service network (FCC11).
