On July 26, 2005, the Verizon Telephone Companies (Verizon) submitted tariff pages under Transmittal No. 604 to introduce Contract Tariff Option No. 30 in Tariff F.C.C. No. 1. Transmittal No. 604 became effective August 10, 2005.

On September 13, 2005, Verizon submitted tariff pages under Transmittal No. 617 to introduce Contract Tariff Option No. 31 in Tariff F.C.C. No. 1. Transmittal No. 617 became effective September 28, 2005.

Original Page 21-256 was originally issued with Contract Tariff Option 30 material under Transmittal No. 604 for effect August 10, 2005. Original Page 21-256 was subsequently inadvertently reissued with Contract Tariff Option 31 material under Transmittal No. 617 for effect September 28, 2005. With this filing, Verizon is reinstating Contract Tariff Option 30 material originally filed on Original Page 21-256 under Transmittal No. 604. This material will now appear on Original Page 21-255.1.
