1. Adding Verizon Regional Value and Verizon Regional Essentials to Residential Generic Optional Calling Plans in FCC Nos. 4, 5, 12 and 15.

2. Adjusting rates for Regional Package and Regional Package Extra in FCC No. 4 and rates for Regional Package Unlimited in FCC Nos. 5 and 12.
3. Adding Pennsylvania to Regional Package, Regional Package Extra and Regional Package Unlimited in FCC No. 15.

The rate adjustments proposed with this filing are allocations and will not result in an increase in the price the customer pays.
