3. SERVICE CLASSIFICATIONS AND RATES (TWO-POINT) (Cont'd)3.7 Generic Optional Calling Plans(A) General

Generic Optional Calling Plans (Plans) are Interstate optional calling plans that must be ordered in conjunction with Intrastate IntraLATA calling plans. The Plans provide an alternate rate treatment for either residential or business customer-dialed Interstate IntraLATA toll calls that are completed without the assistance of an operator.

Customers enrolling in one of the optional Plans will be billed at the rates shown in Sections (3) and (4) following in lieu of the regular Schedule I Interstate IntraLATA rate schedule provided in this tariff.

(B) Regulations

The regulations associated with the Plans as offered under this section include only the applicable regulations set forth in other sections of this tariff and the following regulations, which apply to all Plans.

- (1) The regulations included in this section apply only to Interstate IntraLATA toll calls.
- (2) Plans are available only to customers that have enrolled in a Plan and that have selected this Company as their IntraLATA Toll Provider.
- (3) There is no charge for enrolling or discontinuing a Plan.
- (4) Each Plan is order separately and is not available in conjunction with any other Company-provided Generic Optional Calling Plan, as offered under this section.
- (5) Each Plan allows customers to complete calls 24 hours a day, seven days a week, including holidays.
- (6) Each Plan provides uniform rates that do not vary by time of day or day of week.
