The accompanying tariff material, issued by the Consolidated Communications Companies (CCC; FRN #0010-1553-98), consisting of Consolidated Communications of Texas (CCTX) and Consolidated Communications of Fort Bend (CCFB), d/b/a Consolidated Communications, and bearing Tariff F.C.C. No. 1, Access Service, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. The proposed effective date of December 31, 2005, is fifteen days after the filing date, in accordance with Section 204(a)(3) of the Communications Act of 1934, as amended.

This filing accomplishes five actions:

- (1) Provides a six-month ADSL promotion at a greatly reduced rate,
- (2) Eliminates the exclusion of certain exchanges from the application of the service provider number portability (SPNP)/Local Number Portability (LNP) surcharge,
- (3) Clarifies the application of the multiplex charge for OC3 and OC12 service,
- (4) Updates the mailing address for the Company on the Title Page and Check Sheets (the remainder of the pages will be updated as changes are made)
- (5) Adds a DS1-to-DS0 multiplexing rate by adopting the rate currently applied for DS1-to-Voice Grade, since the two services are essentially the same.

The Description and Justification attached to this letter contains details of each of these tariff changes.
