The Verizon Telephone Companies (Verizon) hereby amend its Application 150 which was filed on December 16, 2005. Application No. 150 was issued to request Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's Rules in order to withdraw material pending under Transmittal No. 653 for its Tariff F.C.C. Nos. 1 and 11 prior to the scheduled effective date of December 27, 2005.

Subsequent to filing Application No. 150, Verizon discovered that the rates pending under Transmittal No. 653 for Tariff F.C.C. No. 1 are the correct rates for that tariff and that Verizon does not need to withdraw the material pending under Transmittal No. 653 for Tariff F.C.C. No. 1. Therefore, Verizon hereby amends Application No. 150 such that it is requesting Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's Rules in order to withdraw only the material pending under Transmittal No. 653 applicable to Tariff F.C.C. No. 11. Additionally, Verizon withdraws the illustrative tariff pages for Tariff F.C.C. No. 1 that were submitted under Application No. 150.
