With this filing, NBTC proposes to introduce OC-3, OC-12, OC-48 and OC-192 Dedicated SONET Ring Service to Sections 22, 26 and 27. Dedicated SONET Ring Service will provide customers with a dedicated custom network to meet their high-speed digital transport needs. Dedicated SONET Ring is based on Synchronous Optical Network (SONET) Uni-Directional Path Switched Ring (UPSR) and Bi-Directional Line Switched Ring (BLSR) technology. The network is in a ring architecture, including sub-rings, designed to provide increased reliability and functionality connecting multiple customer designated locations and specified Telephone Company Central Offices (COs) via self-healing network designs.

In accordance with Section 61.14, this transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) in compliance with the electronic filing procedures.
