With this filing, Verizon is complying with Federal Communications Commission Docket Number 96-262, Access Change Reform; Reform of Access Changes Imposed by Competitive Local Exchange Carriers, Eighth Report and Order and Fifth Order on Reconsideration effective May 14, 2004. To comply with this Order, Verizon will be changing its near out of franchise switched access rates to correspond to the rates of the incumbent carrier.
