This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedures, and proposes the following revisions to Tariff F.C.C. No. 3:

- 1) Addition of rates and regulations offering customers the option of ordering Asynchronous Transport Mode (ATM) service at 4.632 Mbps (3xDS1) and 7.72 Mbps (5xDS1) levels in all Sprint LTC states;
- 2) Adjustment of ATM access termination and interoffice mileage facility (per mile) rates for 1.544 Mbps (DS1), 3.088 Mbps (2xDS1), 6.176 Mbps (4xDS1) and 9.264 Mbps (6x DS1) levels in the state of North Carolina; and
- 3) Addition of a promotional offering waiving the nonrecurring charges when a customer installs a new Sprint Custom Access SolutionsSM arrangement under a three year minimum service period from January 14, 2006 through February 28, 2006.


