Application is hereby made for Special Permission for a waiver of Sections 61.58 and 61.59 of the Commission's Rules to file revisions to the John Staurulakis, Inc. ("JSI") Tariff F.C.C. No. 1, Access Service.

On December 27, 2005, JSI filed Transmittal No. 112 on behalf of the following Comporium Communications Companies: Rock Hill Telephone Company, Lancaster Telephone Company, and Fort Mill Telephone Company ("Comporium Companies") to cancel the companies' respective Asymmetric Digital Subscriber Line ("ADSL") offerings.

The proposed modifications to the tariff to effect the cancellation included both rate page changes and regulation changes. The rate page changes proposed deleting ADSL offerings from the Comporium Companies' respective rate pages.

Based on discussions with Commission Staff, JSI and the Comporium Companies wish to withdraw Transmittal No. 112. A waiver of Section 61.59 is requested to permit JSI to withdraw material that has not yet become effective and to reinstate the previously effective tariff material. A waiver of Section 61.58 is requested to permit the withdrawal filing to become effective on not less than one day's notice.
