Issuing carriers for JSI Tariff FCC No. 1 are listed on Attachment A to this transmittal letter along with the respective FRN number for each carrier and JSI.

This filing, made under authority of Special Permission No. 06-002 of the Federal Communications Commission, withdraws revisions originally filed under Transmittal No. 112 and reinstates the previously effective regulations related to Metallic Access Service, High Capacity Access Service, Synchronous Optical Channel Service, Asynchronous Transfer Mode Cell Relay Service and Asymmetric Digital Subscriber Line (ADSL) Access Service. In addition, this filing reinstates rates for ADSL Access Service for Rock Hill Telephone Company, Lancaster Telephone Company and Fort Mill Telephone Company (these three carriers are affiliates and are collectively the "Comporium Companies"). The Comporium Companies operate in South Carolina. The ADSL rates are reinstated in Section 17.4.8.2 of the respective rate section in the tariff for each of the Comporium Companies. The effective date of the revisions originally filed in Transmittal No. 112 on December 27, 2005, was scheduled for January 11, 2006.


