This filing cancels the Asymmetrical Digital Subscriber Line (ADSL) offerings of the Comporium Companies effective February 10, 2006 pursuant to the *Wireline Broadband Order*.<sup>1</sup>

This filing follows withdrawal by JSI, on behalf of the Comporium Companies, of Transmittal No. 112 which had been filed on December 27th and proposed detariffing of the Comporium Company ADSL offerings effective January 11, 2006. JSI filed the notice concerning the discontinuance with the Commission on December 12, 2005, at which time the Comporium Companies provided notice to other parties. The notice indicated that the Comporium Companies would offer Wireline Broadband Internet Access Service (WBIAS) on a non-common carriage basis following detariffing. After discussions with Commission staff addressing unresolved issues related to provision of WBIAS on a non-common carriage basis by rate-of-return carriers, JSI filed Transmittal No. 114 on January 7, 2006 in order to withdraw Transmittal No. 112. Pursuant to Special Permission No. 06-002, Transmittal No. 114 cancelled the tariff changes filed under Transmittal No. 112 on less than 15-day notice and before being in effect.

Concurrent with this filing, JSI, on behalf of the Comporium Companies, is filing with the Commission Electronic Comment Filing System (ECFS) under CC Docket No. 02-33 an amended notice of intent to discontinue provision of ADSL under tariff. In the amended notice the Comporium Companies indicate their intention to provide WBIAS on a common-carriage detariffed basis effective February 10, 2006. A copy of the notice is provided with this transmittal.

No other issuing carriers for JSI Tariff F.C.C. No. 1 are affected by this filing.
