Issuing carriers for JSI Tariff FCC No. 1 are listed on Attachment A to this transmittal letter along with the respective FRN number for each carrier and JSI.

JSI makes this filing on behalf Home Telephone Company, SAC 240527 (Home) and Pineland Telephone Cooperative, Inc., SAC 220377 (Pineland). Home and Pineland are issuing carriers for JSI Tariff F.C.C. No. 1. Home operates in South Carolina. Pineland operates in Georgia.

On December 30, 2005 JSI filed Transmittal No. 113 in which it, *inter alia*, introduced MultiMedia-Virtual Circuit Channels (MM-VCC) as an optional feature and function for Asynchronous Transfer Mode Cell Relay Access Service (ATM-CRS) on behalf of Home and Pineland. The regulations and rates for the new service became effective January 14, 2006. It has since come to JSI's attention that the following errors in the filing occurred with respect to the rate pages including the MM-VCC rates as follows.


For Home, Original Page 17-529.7 mistakenly indicates that after the base MM-VCC offering of 4 Mbps, incremental capacity is charged on the basis increments of 4 Mbps. This is inconsistent with the regulations for MM-VCCs introduced in Transmittal No. 113 at Section 16.7.4(A)(4)(a)(ii) which provides for base MM-VCC offerings at 4 Mbps and additional capacity in increments of 1 Mbps up to a total capacity per MM-VCC of 16 Mbps. In this filing, JSI proposes correcting the error on the respective MM-VCC rate page of Home by changing the increments of 4 Mbps to increments of 1 Mbps and also adding text to indicate that the maximum capacity per MM-VCC is 16 Mbps.

For Pineland, Original Page 17-356.3 mistakenly indicates a rate of \$6.30 for increments of 4 Mbps after the base capacity of 4 Mbps also at a rate of \$6.30. Pineland set the rate for the base capacity at \$6.30 intending that to apply to MM-VCCs of any capacity from 4 Mbps to the maximum of 16 Mbps. In order to properly reflect Pineland's rate structure, in this filing we propose eliminating the rate for increments above the base and modifying the text for the base capacity rate of \$6.30 to indicate "up to 16 Mbps".
