SECTION 2 - GENERAL REGULATIONS

2.1. Undertaking of the Company

2.1.1. General - IIMTS is the furnishing of those service components required for telecommunications between stations in different states, but within the same LATA in accordance with the regulations and system of charges specified in this tariff. The message charges specified in this tariff are in payment for IIMTS furnished between the calling and called stations. (T)

The Company does not transmit messages. However, IIMTS may be used for that purpose. (T)

2.1.2. Provision of Customer Equipment - Customer equipment may be used with IIMTS. The Company does not provide customer equipment. (T)

2.1.3. Through Transmission of Signals - The Company is responsible for the provision of IIMTS from station to station. It is not responsible for the quality of transmission or signaling on the Customer's side of the interface at a Customer's premises. (T)

2.1.4. Availability of Service (T)

A. The use and restoration of IIMTS will be in accordance with Part 64, Subpart D, of the Federal Communications Commission's Rules and Regulations.

B. Subject to compliance with 2.1.4.A. preceding, where a shortage of service components exists at any time either for temporary or protracted periods, the establishment of two-point IIMTS, provided Under Section 3 of this tariff, shall take precedence over all other services provided by the Company. C. Service is furnished subject to the availability of the service components required. The Company will determine which of those components shall be used and make modifications to those components at its option.

D. When connections are made to Customer- or Other Common Carrier-provided communications systems at a premises where the Customer does not originate or terminate communications, the Company may require that the exchange telephone service be furnished from a Company central office(s) different from the central office(s) designated by the Company to serve that premises.

2.1.5. Limitations on Duration of Connections - The Company reserves the right to limit the duration of connections when necessary because of a shortage of service components caused by emergency conditions.

2.2. USE

2.2.1. General - IIMTS may be used for any lawful purpose consistent with the transmission and switching parameters of the telecommunications network. IIMTS is furnished for use by the Customer but may be used by others when so authorized by the Customer.

2.2.2. Non-Voice Transmission - IIMTS may be used for non-voice transmission on a two-point basis between points within the LATA.

2.2.3. Resale and sharing - Company-provided local business exchange service may be used for the purpose of providing access to resold or shared IIMTS notwithstanding any tariff regulations respecting resale and sharing contained in the Company's General Exchange Tariff.

- 2.2.4. Abuse - The abuse of IIMTS is prohibited. The following activities constitute abuse: (T)
- A. Using IIMTS to make calls, anonymous or otherwise, in a manner which might reasonably be expected to frighten, abuse, torment, or harass another;
  - B. Using profane or obscene language;
  - C. Using IIMTS in such a way that it interferes unreasonably with the use of the service by others.
- 2.2.5. Fraudulent Use - The fraudulent use of, or the intended or attempted fraudulent use of, IIMTS is prohibited. The following activities constitute fraudulent use:
- A. Using IIMTS to transmit a message, locate a person, or otherwise give or obtain information, without payment for the service;
  - B. Using or attempting to use IIMTS with the intent to avoid the payment, either in whole or in part, of the tariffed charges by:
    - 1. Rearranging, tampering with, or making connections not authorized by this tariff to any service components used to furnish IIMTS;
    - 2. Using fraudulent means or devices, tricks, schemes, false or invalid numbers, false credit devices, or electronic devices. (T)

2.3 RESPONSIBILITY OF THE COMPANY

2.3.1. Liability

A. In view of the fact that the Customer has exclusive control of his communications over IIMTS, and of the other uses for IIMTS, and because of the unavailability of errors incident to the use of IIMTS, the services furnished by the Company are subject to the terms, conditions and limitations specified in B. through F. following.

B. The Company's liability, if any, for its willful misconduct is not limited by this tariff. With respect to any other claim or suit, by a Customer or by any others, for damages associated with any aspect of the provision of service (including the failure to reach a called station), and subject to the provisions of C. through F. following, the Company's liability, if any, shall not exceed an amount equal to the initial period charge applicable for such a message to the called station. This liability shall be in addition to any billing adjustments that may otherwise be appropriate.

C. The Company shall be indemnified, defended, and held harmless by the Customer and User against all claims, losses, or damages arising from the use of IIMTS furnished pursuant to this tariff, involving:
