1. Application of Tariff

- 1.1 This tariff contains regulations, rates and charges applicable to the provision of switched Access Service, End User Access Service and Special Access Service. These services are provided to customers by the Beehive Telephone Companies ("BTC" or "Beehive").

Regulations and rates applicable to Carrier Common Line services are the same as those contained in the National Exchange Carrier Association ("NECA") FCC Tariff No. 5.

Pursuant to the Commission's Rules at Sections 69.4(c), 69.5(d), 69.104(1), 69.116, 69.117, 69.603(c), and 69.603(d), regulations concerning administration and billing of Lifeline Assistance and Universal Service Fund, rates and charges for these carrier's carrier elements are contained in Section 8 of NECA Tariff F.C.C. No. 5. NECA will bill and collect all Lifeline Assistance and Universal Service Fund charges on behalf of BTC.

- 1.2 The provision of such services by BTC as set forth in this tariff does not constitute a joint undertaking with the customer for the furnishing of any service.
