Application is hereby made by Nevada Bell Telephone Company (NBTC) for Special Permission to waive Sections 61.58 and 61.59 of the Commission's Rules to 1) withdraw Price Flex rates filed in Transmittal No. 121, and 2) make tariff modifications, based on discussions with Staff, on not less than one day's notice. The revisions proposed in Transmittal No. 121, and the modifications proposed with this filing, will not impact any existing customers.

On March 3, 2006, NBTC filed Transmittal No. 121, which proposed to introduce new features (Flex Ring and DS3 Transmux) to Dedicated SONET Ring Service (DSRS). Additionally, under Transmittal No. 121, NBTC introduced Price Flex rates for the Flex Ring and DS3 Transmux features. The Price Flex rates were filed in error, as new services must be incorporated in Price Cap indices prior to establishing Price Flex rates. The filing also included clarification of existing language and deletion of existing language that is obsolete and no longer applicable to DSRS. The modifications in this filing attempted to standardize the DSRS product offering throughout the enterprise regions. Transmittal No. 121 is scheduled to become effective on March 18, 2006.

NBTC also requests permission to waive Sections 61.58 and 61.59 of the Commission's Rules in order to modify 1st Revised Page 26-4, 1st Revised Page 26-16 and 1st Revised Page 27-5, filed in Transmittal No. 121, based on discussions with Staff. The illustrative tariff pages are attached.

A waiver of Section 61.58 is requested to permit the revision of tariff material to become effective on not less than 1 day's notice. A waiver of Section 61.59 is requested to permit revisions to tariff material that is not yet in effect.
