On March 3, 2006, NBTC filed Transmittal No. 121, which proposed to introduce new features (Flex Ring and DS3 Transmux) to Dedicated SONET Ring Service (DSRS). Additionally, under Transmittal No. 121, NBTC erroneously introduced Price Flex rates for the Flex Ring and DS3 Transmux features. The filing also included clarification of existing language and deletion of existing language that is obsolete and no longer applicable to DSRS. Transmittal No. 121 is scheduled to become effective on March 18, 2006.

With this filing, NBTC wishes to withdraw Price Flex rates filed in Transmittal No. 121 and modify 1st Revised Page 26-4, 1st Revised Page 26-16 and 1st Revised Page 27-5, filed in Transmittal No. 121.
