Qwest is filing tariff changes in its Tariff F.C.C. No. 1, Section 7, Private Line Transport Service and Section 17, Private Line Transport Service – Pricing Flexibility, to add three new ports to the ports contained in Ethernet Ports over SONET (EPoS). These new ports will have maximum speeds of up to 155 Mbps, 622 Mbps or 2.5 Gbps. These ports will provide Ethernet protocol interface for managed optical transport of data signals of various speeds over Qwest provided Synchronous Service Transport (SST) and Self-Healing Network Service (SHNS) and can be used by Ethernet, DS3, OC3 and OC12 circuits. These ports are being added in response to customer requests for these additional services.

Section 61.49(3) of the Commission's Rules allow these new ports to be introduced without cost data.

As part of this filing Qwest is also adding language to Section 2, General Regulations, to address Unbundled Network Element (UNE) to private Line Conversions. In wire centers deemed "non-impaired" by the FCC, UNE circuits that remain with Qwest must convert to special private line service. This conversion involves the ordering and provisioning organizations of Qwest to assure the data for the converted circuit is accurately recorded in the appropriate systems. This conversion of UNE circuits to special private line service will be assessed a Design Change Charge.
