ACS of Anchorage, Inc. ("ACS-ANC"), hereby submits the accompanying tariff material for filing in compliance with the Communications Act of 1934, as amended.

On May 1, 2006, ACS-ANC filed Transmittal No. 29 on an improper notice period. ACS-ANC requested, and was granted, special permission to withdraw the tariff pages prior to them becoming effective.

The first part of this filing, to become effective May 9, 2006, is being filed, on not less than one days' notice, under authority of Special Permission No. 06-018 in order to withdraw the material filed under Transmittal No. 129 without its becoming effective. F.C.C. Tariff No. 1 tariff pages, as appropriately revised, are attached to this transmittal.

Additionally, in this filing, ACS-ANC files a new special arrangement between the Federal Aviation Administration and ACS-ANC to offer a new Special Access optional feature called, "Shared Sonet Ring Interoffice Transport" ("SSRIT"). This portion of the filing is being filed on a streamlined basis on 15-days notice with an effective date of May 23, 2006 and consists of tariff pages as indicated on the following check sheets:
