In accordance with the Commission's March 24, 2006 releases entitled In the Matter of July, 2006 Annual Access Charge Tariff Filings, WCB/Pricing File No. 06-15, Order, DA 06-649, and In the Matter of Material to be Filed in Support of 2006 Annual Access Tariff Filings, WCB/Pricing File No. 06-15, Tariff Review Plans, DA 06-650, the instant filing includes proposed revised rates for the provision of the applicable End User, Switched Access, Special Access and Miscellaneous Services offered by the issuing carriers filing pursuant to Section 61.38 in the JSI Tariff F.C.C. No. 1.

In addition to the required biennial filings for the issuing carriers filing subject to Section 61.38 of the Commission's rules, this transmittal includes a proposed revision in the Federal Universal Service Contribution (FUSC) Factor for Interstate Telephone Company (Interstate) reflective of the decrease in the Universal Service Contribution Factor from 10.9% to 10.5% for the third quarter of 2006. Proposed Third Quarter Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 06-1252 (released June 9, 2006). Interstate is not a member of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

This filing also serves to remove End User Common Line, Switched Access, Special Access, and Miscellaneous Services rates from JSI Tariff F.C.C. No. 1 for Warwick Valley Telephone Company (WVTC). WVTC operates in New York and New Jersey. Concurrent with the effective date of this filing, July 1, 2006, WVTC will reenter the NECA Common Line and Traffic Sensitive Pools and will become an issuing carrier for NECA Tariff F.C.C. No. 5.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$720.00 have been sent via overnight delivery to the Mellon Bank, Pittsburgh, Pennsylvania, as of this date.

Customers will be notified of the proposed changes in accordance with the Commission's requirements.

As a participant in the NECA Common Line pool, CTC bills the Federal Universal Service Charge (FUSC) under NECA Tariff F.C.C. No. 5.
- (3) Interstate Telephone Company is not a member of either the NECA Common Line Pool or the NECA Traffic Sensitive Pool. Interstate carrier bills for both Common Line and Traffic Sensitive under rates established in JSI Tariff FCC No. 1, including the Federal Universal Service Charge (FUSC). Accordingly, quarterly filings are made at such time as the Commission announces changes in the Federal Universal Service Contribution factor.
- (4) Warwick Valley Telephone Company is rejoining the NECA Common Line and Traffic Sensitive Pools effective July 1, 2006. All Common Line (CL) and Traffic Sensitive (TS) (Switched Access, Special Access, Miscellaneous Charges and DSL Access) are being removed from JSI Tariff FCC No. 1 effective July 1, 2006.
- (5) Horry Telephone Cooperative, Inc. has elected to file on 7 days notice on June 26, 2006 due all rate revisions comprising reductions.
