# Effective April 1, 2006, the DSL Access Services Discount Pricing Arrangement (DPA) will no longer be available to new customers. A customer with an existing DPA Term Plan on April 1, 2006 may continue service at the SWC associated with that term plan until the expiration of the commitment period. If at the end of the grandfathered DPA Term Plan commitment the customer has not elected to establish a new DSL Access Services Wholesale Rate Plan (WRP) as described in Section 8.4, following, the customer will be billed the DPA Monthly Plan Line Charges specified in Section 17.4.9(C)(1), following, for its in-service ADSL and/or SDSL Access Service lines. The customer may convert an existing grandfathered DPA Term Plan commitment to a new DSL WRP Term Plan commitment at any time without the application of a termination liability charge. The Access Order Charge to establish the replacement DSL WRP Term Plan commitment will also be waived.
