John Staurulakis, Inc. ("JSI"), on behalf of Hargray Communications Group, Inc. and its affiliates Hargray Telephone Company, Inc. and Bluffton Telephone Company, Inc. (collectively "the Company") respectfully files the attached notice pursuant to the *Wireline Broadband Order* of the intent of the Company to discontinue its Wireline Broadband Internet Access Transmission Service (WBIATS) offerings under JSI Tariff F.C.C. No. 1 effective August 1, 2006. Upon discontinuance of the tariffed offerings, the Company will provide WBIATS on a common-carriage non-tariffed basis. See *Appropriate Framework for Broadband Access to the Internet over Wireline Facilities, Universal Service Obligations of Broadband Providers*, CC Docket No. 02-33, WC Docket No. 05-271, Report and Order and Notice of Proposed Rulemaking, 20 FCC Rcd 14853 (2005), FCC 05-150 (Rel. Hargray Communications Group, Inc. and its affiliates Hargray Telephone Company, Inc. and Bluffton Telephone Company, Inc. (individually “HCGI”, “Hargray” and “Bluffton”, respectively, and collectively “the Company”) hereby provide notice that the Company plans to terminate provision of wireline broadband Internet access transmission service (WBIATS) on a tariffed basis effective August 1, 2006 at which time it plans to offer permissive detariffed WBIATS on a Title II common-carriage basis pursuant to paragraph 94 of the Federal Communications Commission’s *Wireline Broadband Order*.¹ Hargray and Bluffton currently offer WBIATS through High Speed Internet (“HSI”) Access Service under John Staurulakis, Inc. (“JSI”) Tariff F.C.C. No. 1, for which they are issuing carriers.

In order to effect the permissive detariffing, JSI plans to make a filing with the Federal Communication Commission on July 17, 2006 on 15-day notice to cancel the Company’s HSI Access Service offerings.

Impact on Customers

The only customer for the Company’s HSI Access Service is the nonregulated Internet Service Provider (“ISP”) operation of the Company. HSI Access Service is purchased by the nonregulated operations of the Company as a component in broadband Internet service sold to consumers and business customers. The discontinuance of the tariffed offering of HSI Access Service will have no effect on the end user service provided by Company.

Future Availability of WBIATS on a Permissive-Detariffed Common Carriage Basis

The Company will continue to make WBIATS available on a common-carriage basis through posting of rates, terms and conditions on its Internet web-site in a manner similar to that required for interstate and international interexchange services under Section 42.10 of the FCC’s rules (47 C.F.R. § 42.10). The initial rates will be those offered under tariff. Any change in rates, terms and conditions will be made on fifteen-day advance notice to customers and shall apply to both the affiliates and non-affiliates on a non-discriminatory basis. Cost allocations related to WBIATS will continue to be handled as under the *status quo*.

Planned tariff filing to become effective. Beginning on this date the Company will no longer offer WBIATS under JSI Tariff F.C.C. No. 1.
