Citizens Telecommunications Companies ("Citizens") submits this application for special permission to request waiver of §61.58 and §61.59 of the Federal Communications Commission's rules in order to withdraw material filed under Transmittal No. 168 on not less than one day's notice.

On July 17, 2006 Citizens issued Transmittal No. 168 with a proposed effective date of August 1, 2006. With Transmittal No. 168, Citizens sought to revise tariff language dealing with customer audits of bills, provision of duplicate invoices, and End User Common Line (EUCL) terms and conditions. Discussions with the Commission's Staff indicate that it will be necessary to modify the language submitted under Transmittal No. 168. Citizens seeks the above-cited waiver of §61.58 and §61.59 in order to withdraw this material without its becoming effective, restore currently effective material, and allow time for further discussions with Staff as to what language will meet Staff's concerns.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of seven hundred twenty dollars (\$720.00), has been paid by credit card and an electronic Form 159 has been submitted.
