Dear Secretary:

The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens") and scheduled to become effective July 28, 2006, is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing, Citizens withdraws material filed under Transmittal No. 168, currently scheduled to become effective on August 1, 2006, and restores the currently effective tariff material.

On July 17, 2006 Citizens issued Transmittal No. 168 with a proposed effective date of August 1, 2006. With Transmittal No. 168, Citizens sought to revise tariff language dealing with customer audits of bills, provision of duplicate invoices, and End User Common Line (EUCL) terms and conditions. At the request of the Commission's Staff, this material is being withdrawn to allow time for further discussion as to what language will meet Staff's concerns. This filing relies on waivers of \$61.58 and \$61.59 of the Commission's rules granted under authority of Special Permission No. 06-027.

In accordance with the Commission's fee filing requirements, a filing fee in the amount of seven hundred twenty dollars (\$720.00), has been paid by credit card and an electronic Form 159 has been submitted.
