The F.C.C. Registration Number (FRN) for JSI is 0003-7481-42. The FRNs for the issuing carriers for JSI Tariff F.C.C. No. 1 are provided on Appendix A to this transmittal letter.

The filing, to become effective September 30, 2006, consists of tariff pages as indicated on the following checksheet:

For Interstate Telephone Company (Interstate), this filing proposes revision of the Federal Universal Service Charge (FUSC) factor reflective of the decrease in the Universal Service Contribution Factor from 10.5% to 9.1% for the fourth quarter of 2006. Proposed Fourth Quarter 2006 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 06-1812 (released September 11, 2006). Interstate is not a member of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

For The Concord Telephone Company (Concord), this filing proposes revisions to properly indicate that Concord bills the FUSC pursuant to the regulations and rates in NECA Tariff F.C.C. No. 5. Concord is listed in NECA Tariff F.C.C. No. 5 as a carrier billing the FUSC under NECA Tariff F.C.C. No. 5.

For Smart City Telecom, this filing cancels the Wireline Broadband Internet Access Transmission Service (WBIATS) offerings of Smart City Telecom pursuant to paragraph 94 of the Commission's Wireline Broadband Order.<sup>1</sup> Smart City Telecom currently offers WBIATS under the Wholesale Digital Subscriber Line (DSL) Access Service regulations in JSI Tariff F.C.C. No. 1. Concomitant with the cancellation of the Smart City Telecom Wholesale DSL Access Service, this filing also proposes cancellation of ATM-CRS port connection offerings provided by the company for DSL access connection purposes.

With this filing, JSI also proposes removal of the Wholesale DSL regulations in JSI Tariff F.C.C. No. 1. With the cancellation of the Smart City Telecom Wholesale DSL offerings, no issuing carriers for JSI Tariff F.C.C. No. 1 offer Wholesale DSL. Out of the 16 issuing carriers for JSI Tariff F.C.C. No. 1, only four provide WBIATS under the tariff. Those four offer WBIATS under separate ADSL, SDSL and High Speed Internet Access Service regulations that will remain in the tariff.

As indicated in Smart City Telecom's permissive detariffing notice filed with the Commission through the FCC Electronic Comment Filing System (ECFS) in CC Docket 02-33 on August 31, 2006, Smart City Telecom will offer wireline broadband Internet transport service on a permissive non-tariffed common carriage basis under Title II

beginning September 30, 2006. Ethernet port for WBIATS access connections will also be offered on a common carriage basis under Title II. A copy of the Smart City Telecom 30-day notice is included with this filing.

Additionally in this filing, JSI is removing Warwick Valley Telephone Company (Warwick) from the list at Section 3 of issuing carriers billing end user charges pursuant to regulations in JSI Tariff F.C.C. No. 1. As part of the 2006 annual filing effective July 1, 2006, Warwick cancelled as an issuing carrier for JSI Tariff F.C.C. No. 1 and reentered the NECA common line and traffic sensitive pools and became an issuing carrier for NECA Tariff F.C.C. No. 5. JSI inadvertently overlooked removing Warwick from Section 3 at the time of the annual filing.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$720.00 have been sent via overnight delivery to the Mellon Bank, Pittsburgh, Pennsylvania, as of this date.
