On November 2, 2006, NBTC filed Transmittal No. 145 which proposed various modifications to its Tariff F.C.C. No. 1. The modifications added clarifying language to the Expedite Charges Section of the tariff to explain the applicable charges processed when an expedited service date is missed due to the customer not being ready for service. Transmittal 145 is scheduled to become effective on November 17, 2006.
