For Interstate Telephone Company (Interstate), this filing proposes revision of the Federal Universal Service Charge (FUSC) factor reflective of the increase in the Universal Service Contribution Factor from 9.1% to 9.7% for the first quarter of 2007. See Proposed First Quarter 2007 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 06-2506 (released December 13, 2006). Interstate is not a member of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.
