The accompanying tariff material, issued by the Consolidated Communications Companies (CCC; FRN #0010-1553-98), consisting of Consolidated Communications of Texas (CCTX) and Consolidated Communications of Fort Bend (CCFB), d/b/a Consolidated Communications, and bearing Tariff F.C.C. No. 1, Access Service, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. The proposed effective date of January 31, 2007, is the required fifteen days after the filing date, in accordance with Section 204(a)(3) of the Communications Act of 1934, as amended.

This filing introduces a new Stand Alone DSL service to our customers. This filing also reflects a correction to our CCFB Section 18 DS1-DS3 Channel Termination rates for our 1 year Discount Plan. This change is less than \$0.15 which was a typographical error. The original cost work reflects the correct rate which was filed with our June 16, 2006 annual access charge filing in Transmittal No. 12.

The Description and Justification attached to this letter contains details of each of the new Stand Alone DSL service.
