1. APPLICATION OF TARIFF

- 1.1 This tariff applies to Interstate IntraLATA Message Telecommunications Service furnished by Verizon Pennsylvania Inc. (hereinafter referred to as this Company), or furnished jointly by this Company, Verizon Delaware LLC, and concurring, connecting or other participating carriers, or furnished by concurring and connecting carriers, as set forth below in 1.1.1 through 1.1.5. Service under this tariff is furnished only between stations within the LATAs of Verizon Pennsylvania Inc. (C)
- 1.1.1 Interstate service between points as specified in 3.1 following.
 - 1.1.2 Public land mobile radiotelephone service as specified in 3.4 following.
 - 1.1.3 Maritime Mobile Radiotelephone Service as specified in 3.5 following.
 - 1.1.4 Aviation Radiotelephone Service as specified in 3.6 following.
 - 1.1.5 Conference Service as specified in 4.1.

2.3 Obligations of the Customer (Cont'd)

2.3.3 (Cont'd)

(C) Ensuring that no charge by the aggregator to the consumer for using a "800" or "950" access code number, or any other access code number, is greater than the amount the aggregator charges for calls placed using the presubscribed provider of operator services.

The requirements of paragraph (A) shall not apply to an aggregator in any case in which State law or State regulation requires the aggregator to take actions that are substantially the same as those required in paragraph (A).

3.5 Maritime Mobile Radiotelephone Service3.5.1 VHF Service - Through Land Stations of This Company and Concurring Carriers(A) Application

- (1) VHF Service is a two-way communication service furnished through the following land radiotelephone stations. These stations are licensed to provide a maritime mobile service which is primarily of a local character.

- (2) VHF Service is available to ships equipped for this service when within range of a VHF Service Station through which such service is furnished. Service is furnished subject to transmission, atmospheric and like limitations.
- (3) The services offered are those referred to in (C)(1) and in (C)(2) following.
- (4) Conference service is not available to ships served through VHF Service Stations listed in (A)(1) preceding.

(B) Regulations

- (1) Service is offered on a Dial Station, an Operator Station, and Marine Identification Number (MIN) card basis. However, person-to-person calls and MIN card calls will only be accepted from ships. Person-to-person calls, and MIN card calls will not be completed to the ship.
