COMMENTS OF SPRINT NEXTEL CORPORATION

Sprint Nextel Corporation, pursuant to the Public Notice released on January 29, 2007 (DA 07-278), hereby respectfully submits its comments on the Indiana Bell and Ohio Bell (collectively, "Ameritech") petitions for Phase I and II pricing flexibility for certain special access and dedicated transport services in the Kokomo, IN and Youngstown-Warren, OH Metropolitan Statistical Areas (MSAs). While Ameritech may technically have satisfied the triggers that allow pricing flexibility, the record is clear that these triggers fail to accurately measure the true state of competition in the special access and dedicated transport markets. To grant the instant petitions based on these flawed triggers would only exacerbate an already problematic situation, and cause further pricing anomalies in these markets. Therefore, Ameritech's petitions for pricing flexibility should be denied pending adoption by the Federal Communications Commission

("FCC") of new pricing flexibility triggers which better reflect competitive conditions in the special access and dedicated transport markets.¹

When the currently effective pricing flexibility triggers were adopted in 1999, the Commission anticipated that the presence of alternative providers (as measured by independent competitors collocated in a certain percentage of the ILEC's wire centers in a MSA) would "ensure that rates [for the special access and dedicated transport services at issue] are just and reasonable."² Unfortunately, reality has not lived up to these expectations.³ Ameritech, like the other BOCs, has retained its market power in the provision of special access and dedicated transport services, as evidenced by its supracompetitive returns and excessively priced interstate rates. As seen from Attachment 1, in MSAs where it already has been given pricing flexibility, Ameritech charges rates for DS1 and DS3 services that exceed price capped rates by up to 93% and 37%, respectively.⁴ These rates helped Ameritech-Indiana earn 97%, and Ameritech-Ohio earn 98%, on their interstate special access services in 2005.⁵ These results are hardly typical of an effectively competitive market.



Given such pricing and rate of return results, one must conclude that the interstate special access and dedicated transport markets in Indiana Bell and Ohio Bell territory are not yet competitive, irrespective of whether some arbitrary pricing flexibility trigger has been met. To ensure that rates for such services are truly just and reasonable, a decision on Ameritech's request for pricing flexibility should be deferred until such time as the Commission has adopted triggers which more accurately reflect the state of competition, and Ameritech has demonstrated that it has met such revised triggers.
