ADSL provides high speed data access over the Company's local exchange service facilities. ADSL allows customers to access the Internet using a dedicated high speed data connection, while simultaneously using the public switched network for voice calls. ADSL voice-data provides transmission of data signals at a maximum data transmission

speed of 1 Mbps upstream and 10 Mbps downstream using the Company's local exchange service line.
