23 – Metropolitan Statistical Area Access Services

23.1 General Regulations

- A. This Section of the Tariff provides the regulations, rates and terms and conditions that apply to telecommunications services provided by the Company in the Metropolitan Statistical Areas (MSAs) in which the Company has received Phase II pricing flexibility pursuant to Subpart H of Part 69 of the Commission's Rules. MSAs are divided into two categories: Full Service Relief MSAs and Limited Service Relief MSAs.
1. Full Service Relief MSAs are those MSAs in which the Company has qualified for Phase II pricing flexibility for all elements of service, i.e., local channels (channel terminations) between LEC end offices and customer (end user) premises; entrance facilities; dedicated interoffice facilities; local channels (channel terminations) between an interexchange carrier's point of presence and a serving wire center. The Full Service Relief MSAs are set forth in Section 23.2.A.1 following.
 2. Limited Service Relief MSAs are those MSAs in which the Company has qualified for Phase II pricing flexibility for all elements of service except local channels (channel terminations) between a LEC end office and a customer (end user) premises. The Limited Service Relief MSAs are set forth in Section 23.2.B.1 following.
- B. The services provided in MSAs pursuant to this Section of the Tariff are set forth in Section 23.3 following.
1. The services in Section 23.3 following are comparable to BellSouth SWA Dedicated Transport Services in Sections 6.8.1.A, 6.8.1.B.1, 6.8.1.C.2, 6.8.1.C.3, 6.8.1.E, 6.8.1.G.5, 6.8.1.G.6, 6.8.1.H through 6.8.1.M, and 6.8.5 through 6.8.10; Special Access (a.k.a. BellSouth SPA) Services in Section 7; Fast Packet Access Services in Section 21; Digital Subscriber Line Access Services in Section 28 and Optical Transport Access Services in Section 29 of this Tariff.
 2. The general regulations, service descriptions and rate regulations for BellSouth SWA Dedicated Transport Services in Sections 6.1, 6.1.1, 6.1.2, 6.1.3.A, 6.1.3.C, 6.1.4 through 6.1.8, 6.2.10, 6.2.12, 6.5 through 6.7; Special Access (a.k.a. BellSouth SPA) Services in Section 7; Fast Packet Access Services in Section 21; Digital Subscriber Line Access Services in Section 28 and Optical Transport Access Services in Section 29 are also applicable to the services specified in this Section. Where regulations for BellSouth SWA Dedicated Transport Services in Sections 6.1, 6.1.1, 6.1.2, 6.1.3.A, 6.1.3.C, 6.1.4 through 6.1.8, 6.2.10, 6.2.12, 6.5 through 6.7; Special Access (a.k.a. BellSouth SPA) Services in Section 7; Fast Packet Access Services in Section 21; Digital Subscriber Line Access Services in Section 28 and Optical Transport Access Services in Section 29 of this Tariff conflict with those in this Section, the regulations specified herein will supercede any inconsistencies.
