Disaster Recover Access Links provide diversely transport capabilities for the purposes of disaster recovery associated with critical national security communications at the John C. Stennis Space Center. Disaster Recover Access Links provide an interLATA connection between the customer's premises at the John C. Stennis Space Center in the Biloxi Mississippi LATA to the BellSouth Jackson Pearl Central Office in the Jackson Mississippi LATA, where the Access Links will connect to standard tariff services for further connection to the customer's network.

Disaster Recover Access Links service components available under this tariff are for a minimum of sixty months and subscription to each of these services obligates the customer to pay all access link service charges set forth in this tariff during the sixty month term for the Disaster Recover Access Links. Disaster Recover Access Links contain nonrecurring and recurring charges that are applicable to the service components as follows:

- Access Links contain a nonrecurring charge associated with the installation of the service and a monthly recurring charge associated with the service's facilities. The recurring charges are based on a 60 Month Commitment Period (i.e., 60 Month Commitment Monthly Rates) and Month-to-Month rates. The 60 Month Commitment Monthly Rate is applicable each month, for sixty months, beginning with the initial installation of the service. For the OC-192 Access Link With Service Level Visibility, the 60 Month Commitment Period recurring charge has been converted to a nonrecurring amount and included in the service component's nonrecurring charge. Month-to-Month rates for Access Links are applicable only upon completion of a 60 Month Commitment Period. Commitment Plan rates are stabilized over the sixty month term and are not subject to increases.

- Service Level Interfaces are available for use with the OC-192 Access Link With Service Level Visibility and contain nonrecurring and recurring charges. The nonrecurring charge is associated with the installation of an interface and applies per interface. The recurring charge is a Month-to-Month rate that is applicable only during the time period an interface is in-service. The recurring charges for the Service Level Interfaces are not rate stabilized and are payable for the time period they are activated on the OC-192 Access Link With Service Level Visibility. (N)
- Customer Network Management (CNM) Surveillance service components provide the customer the ability to monitor the performance of an Access Link. CNM service components apply per customer or central office location on a OC-192 Access Link. (N)
