The Verizon Telephone Companies (Verizon) apply for Special Permission for a waiver of Section 61.74 of the Commission's Rules.

Verizon plans to introduce a new contract tariff option (Option) in its Access Service Tariff F.C.C. No. 1 (FCC 1) and Access Service Tariff F.C.C. No. 11 (FCC 11). This new Option will provide a customer with Billing Credits on its Facilities Management Service (FMS) rate elements when the customer maintains a minimum number of FMS Transport Miles and satisfies other specific eligibility criteria as set forth in this Option. To describe the terms, conditions, and eligibility requirements for this new Option, FCC 1 and FCC 11 must refer to each other and to Verizon's Tariffs F.C.C. No. 14 (FCC 14), Facilities for Interstate Access, and No. 16 (FCC 16), Access Service.

Verizon, therefore, requests special permission to waive the requirements of Section 61.74 of the Commission's Rules in order to allow FCC 1 and FCC 11 to reference each other and to reference FCC 14 and FCC 16 for the reasons stated above.
