Under authority of Special Permission No. 07-004 of the Federal Communications Commission, Verizon is submitting tariff pages to introduce a new contract tariff option (Contract Option). This new Contract Option will provide a customer with Billing Credits on its Facilities Management Service (FMS) rate elements when the customer maintains a minimum number of FMS Transport Miles and satisfies other specific eligibility criteria as set forth in this Contract Option. This new Contract Option is being filed in Tariff F.C.C. No. 1 and Tariff F.C.C. No. 11, where Verizon has received Pricing Flexibility relief for Special Access Services in Qualifying MSAs.

Supporting material as specified under Section 61.49 of the Commission's Rules is not required with this filing.
