With this filing Verizon is providing for Special Construction of facilities to provision tariffed services in Tariff FCC No. 21 for: MA – John Hancock Life Insurance USA; NY – MCI Communications Inc.; NJ - MCI Telecommunications Inc.; MD – Cellco Partnership d/b/a Verizon Wireless, Constellation Energy Group, Inc.; FL – AT&T Corporation, Sprint Communications Company; TX - Cellco Partnership d/b/a Verizon Wireless; IN – Norfolk Southern.

Also with this filing, Verizon is amending a case to revise the non-recurring charge filed in Transmittal No. 786, effective March 15, 2007. This case is being amended to reflect the amendment to the contract due to customer's request to change the original 25-pair copper cable to a 50-pair copper cable. This customer-requested change increased the cost for providing the requesting facilities, and the non-recurring charge was increased accordingly, as reflected in this transmittal.

Supporting material as specified under Section 61.38 of the Commission's Rules is included with this filing.


This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
