The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's Rules.

On May 25, 2007, Verizon filed Transmittal No. 810. Verizon asked to clarify tariff language to allow for collection of all costs that have been incurred by the Telephone Company for special construction in the event that the customer cancels its request prior to the start of service. The change to the tariff was filed in Transmittal No. 810 and is scheduled to become effective June 9, 2007.

Verizon wishes to withdraw the filing made in Tariff FCC No. 21. As a result, Verizon requests special permission to waive the requirements of Section 61.58 and 61.59 of the Commission's Rules in order to withdraw the material pending under Transmittal No. 810 prior to its scheduled effective date of June 9, 2007.


