**Re: Application for Special Permission**

Dear Ms. Dortch:

Alliance Communications Cooperative, Inc. (Alliance) (FRN #0005-0971-59), hereby requests Special Permission to make a filing on less than the notice required in Section 61.58 of the Commission's Rules and a waiver of 61.59 of the Commission's Rules in order to correct the pending Transmittal No. 7 (Issued: June 15, 2007) of its Tariff F.C.C. No. 2, Access Service, and the pending Transmittal No. 8 (Issued: June 15, 2007) of its Tariff F.C.C. No. 1, Access Service, to add a provision that was inadvertently omitted or changed.

Specifically on its Tariff F.C.C. No. 2, Alliance requests Special Permission to restore: (a) a portion of the DSL Access Service Discount Pricing Arrangement Term Plans in Section 17.4.9 (C) and the DSL Access Service Wholesale Rate Plans in Section 17.4.9(G) to its tariff; and (b) eliminate NECA tariff 4 references and rates that are not valid or applicable to Alliance in sections 8., 17.3.8 (B), 17.4.4 (P). Alliance understands that it will not be entitled to "deemed lawful" status under Section 214(a)(3) of the Communications Act for these particular rates.

Specifically on its Tariff F.C.C. No. 1, Alliance requests Special Permission to restore: (a) a footnote regarding its Presubscription in Section 17.4.4(I) on Page 61 of the tariff; and (b) a portion of the DSL Access Service Discount Pricing Arrangement Term Plans in Section 17.4.9(C). Alliance understands that it will not be entitled to "deemed lawful" status under Section 214(a)(3) of the Communications Act for these particular rates.

These charges are to be effective on June 30, 2007, as with the initial filing.


