No. 1, effective June 30, 2007, are sent to you in compliance with the Communications Act of 1934, as amended and pursuant to the Commission's Rules.

This filing is made pursuant to Special Permission No. 07-014 to restore DSL Access Service Term Plans and to reinstate material that was inadvertently omitted under Transmittal No. 7 of its Tariff F.C.C. No. 2. Alliance understands that it will not be entitled to "deemed lawful" status under Section 204(a)(3) of the Communications Act for the reinstated "DSL Access Service Discount Pricing Arrangement Term Plans" and the "DSL Access Service Wholesale Rate Plans"

This filing is also made pursuant to Special Permission No. 07-014 to restore DSL Access Service Discount Pricing Arrangement Term Plans and reinstate material that was inadvertently deleted under Transmittal No. 8 of its Tariff F.C.C. No. 1. Alliance understands that it will not be entitled to "deemed lawful" status under Section 204(a)(3) of the Communications Act for these particular rates.


