ACCESS SERVICE**1. APPLICATION OF TARIFF**

- 1.1 This tariff contains rates and charges applicable to the provision of Switched Access and Special Access Services, and other miscellaneous services, hereinafter referred to collectively as service(s), provided by Chariton Valley Telephone Corporation, hereinafter referred to as the Telephone Company, to customers. This tariff also contains Access Ordering charges that are applicable when these services are ordered or modified by the customer. The Telephone Company participates in the NECA Tariff F.C.C. No. 5 for Carrier Common Line Services, End User Common Line, Lifeline Assistance, and Universal Service Fund Services, therefore the rates and charges for these services are as provided in the NECA F.C.C. Tariff No. 5.
- 1.2 The provision of such service by the Telephone Company as set forth in this tariff does not constitute a joint undertaking with the Customer for the furnishing of any service.
- 1.3 Chariton Valley Telephone Corporation in accordance with the provisions of Part 61.39(a) of the FCC's Rules and Regulations did elect to file its own tariff and reference the regulations, terms and conditions of the National Exchange Carrier Association, Inc. (NECA) Tariff F.C.C. No. 5, Access Service, for the General Regulations, End User Common Line, Carrier Common Line, Switched Services, Special Access, Lifeline Assistance, and Universal Service Fund Services, and other miscellaneous services contained therein. Regulations, terms, and conditions applicable to these services are therefore specifically cross referenced and included in the following sections of the National Exchange Carrier Association, Inc. Access Service Tariff F.C.C. No. 5:
