With this transmittal, Verizon is proposing modifications to Integrated Optical Service Riders in Tariff FCC Nos. 1 and 14. The rate structure for Integrated Optical Service Riders was inadvertently introduced using Rate Zones 1-3. This filing collapses the rate zone structure into a non-zoned rate structure.
