This filing proposes revisions on behalf of Atlantic Telephone Membership Corporation ("Atlantic") operating in North Carolina, SAC 230468.

This filing cancels the Wireline Broadband Internet Access Transmission Service ("WBIATS") offerings of Atlantic, pursuant to paragraph 94 of the Commission's Wireline Broadband Order.¹ Atlantic currently offers WBIATS under Asymmetric

Digital Subscriber Line (“ADSL”) Access Service and Symmetric Digital Subscriber Line (“SDSL”) Access Service regulations in JSI Tariff F.C.C. No. 1.

As indicated in the permissive detariffing notice filed with the Commission through the FCC Electronic Comment Filing System (ECFS) in CC Docket 02-33 on July 17, 2007, Atlantic, will offer wireline broadband Internet transport service on a permissive non-tariffed common carriage basis under Title II beginning September 1, 2007. A copy of the Atlantic 30-day notice is included with this filing.

In addition to the revisions mentioned above, this filing also proposes revisions to pages 16-12 and 16-21 to remove Atlantic from the list of carriers offering ADSL and SDSL Access Service. Finally, this filing deletes the indication of Coastal Utilities, Inc. (Coastal) as an issuing carrier offering SDSL Access Services. Coastal exited the JSI Tariff in Transmittal No. 104 effective December 9, 2004. JSI inadvertently neglected to remove Coastal from the table on page 16-21 indicating carriers offering SDSL Access Services. JSI proposes to correct the oversight as part of the instant transmittal.

Support for the Atlantic filing is limited to the 30-day permissive detariffing notice.
