On July 11, 2007, John Staurulakis, Inc. (JSI) filed a notice on behalf of Atlantic Telephone Membership Corporation ("Company"), an issuing carrier for John Staurulakis, Inc. ("JSI") Tariff F.C.C. No. 1, pursuant to the *Wireline Broadband Order* of the intent of the Company to discontinue its Wireline Broadband Internet Access Service (WBIAS) offerings under JSI Tariff F.C.C. No. 1 effective August 10, 2007. With this supplemental filing, the Company amends the effective date for detariffing to September 1, 2007.

As indicated in the original, July 11, 2007 notice, upon discontinuance of the tariffed offerings, the Company will provide WBIAS on a common-carriage non-tariffed basis. See *Appropriate Framework for Broadband Access to the Internet over Wireline Facilities, Universal Service Obligations of Broadband Providers*, CC Docket No. 02-33, WC Docket No. 05-271, Report and Order and Notice of Proposed Rulemaking, 20 FCC Rcd 14853 (2005), FCC 05-150 (Rel. Sept. 23, 2005), (*Wireline Broadband Order*).

Amendment of the effective date to move it back twenty-one days from August 10, 2007 to September 1, 2007 allows better coordination of the migration to provision of WBIAS on a permissively detariffed basis under rates, terms and conditions available on the Company's web site. Additionally, a correction has been made to the timeline to indicate that the only current customers for the Company's tariffed-DSL Access Services are end user customers of the Company who order it out of the tariff on a retail basis for combination with separately purchased Internet service from the ISP of their choosing.

Atlantic Telephone Membership Corporation (“Company”) hereby provides notice that it plans to terminate provision of wireline broadband Internet access service (WBIAS) on a tariffed basis effective September 1, 2007 at which time it plans to offer permissive detariffed WBIAS on a Title II common-carriage basis pursuant to paragraph 94 of the Federal Communications Commission’s *Wireline Broadband Order*.¹ The Company currently offers WBIAS through Asymmetric Digital Subscriber Line (“ADSL”) Access Service and Symmetric Digital Subscriber Line (“SDSL”) Access Service under John Staurulakis, Inc. (“JSI”) Tariff F.C.C. No. 1, for which the Company is an issuing carrier.

The Company has directed JSI that it remove the Company as a carrier listed in JSI Tariff F.C.C. No. 1 as a provider of ADSL and SDSL Access Services (hereinafter “WBIAS”) under the tariff effective September 1, 2007.

Impact on Customers

Current customers for WBIAS comprise exclusively end user customers of the Company who order DSL Access Service pursuant to JSI Tariff F.C.C. No. 1 as a retail offering. The end user customers use the DSL Access Service jointly with a separately purchased ISP service. Discrete charges for DSL Access Service at tariffed-rates appear on customer bills. The Company does not expect detariffing to have any effect on end user customers.

Serving Area

The company’s provision of WBIAS is limited to its ILEC serving areas in rural southeastern North Carolina.

Future Availability of WBIAS on a Permissive-Detariffed Common Carriage Basis

The Company will continue to make WBIAS available on a common-carriage basis through posting of rates, terms and conditions on its Internet web-site in a manner similar to that required for interstate and international interexchange services under Section 42.10 of the FCC’s rules (47 C.F.R. § 42.10).
