This filing proposes revisions to the carrier-specific rate sections for the issuing carriers listed below. The proposed revisions are for the purpose of adding the safe harbor refile trigger procedure prescribed by the Commission in the *Investigation of Certain 2007 Annual Access Tariffs*, WC Docket No. 07-184, WCB/Pricing No. 07-10, Order Designating Issues for Investigation, DA 07-3738 (Rel. August 24, 2007) at paragraph 28 (*2007 Access Filing Designation Order*). The refile trigger establishes a duty for the carrier or, in the case of the TDS Telecom Companies the group of carriers with pooled rates and demand, to file revised rates should switched access minutes of use (MOUs) for a month in the tariff period increase over the same month in the preceding year at a rate greater than 100 percent.
