#### **4. MISCELLANEOUS SERVICES**

##### **4.1 FEDERAL UNIVERSAL SERVICE FUND CHARGE**

The Federal Universal Service Fund Charge is assessed monthly to end user customers who obtain services from this Tariff to recover contributions for the Universal Service Support Mechanisms. Lifeline customers and resellers (carriers that purchase services for resale and certify to the Company that they contribute to support universal service) are excluded from this charge. This charge is determined by multiplying a factor, specified following, times the total of the end user customer's monthly charges billed for services from this Tariff.
